



CHIOMENTI FASHION LAW AWARD Master of Law (LL.M.) in Fashion Law a.y. 2019/2020

ART. 1 - SUBJECT

- Following the support of Chiomenti Studio Legale, Luiss School of Law is pleased to announce the "Chiomenti Fashion Law Award", one (1) prize for candidates enrolled in the Second Level Master/LL.M. in Fashion Law (hereafter Master) during the academic year 2019/2020.
- The prize consists of a scholarship amounting to EUR 8,548.

ART. 2 - PARTICIPATION

The competition is open to all candidates enrolled during the a.y. 2019/2020 in the Master of Law in Fashion Law, who will comply with the following requirements:

- The candidate has successfully passed each and every partial exam as foreseen by the Master's program, with a minimum average mark of 28 upon 30.
- The candidate has successfully submitted its final thesis before July 31, 2020.
- The candidate has attended no less than the 90% of the total class hours.
- The absence of any of the aforementioned requirements involves the immediate exclusion from the list of eligible candidates.

ART. 3 – INCOMPATIBILITY

 The prize is incompatible with any other study grants and/or scholarships offered by a public body or private organizations based in Italy.

ART. 4 – ASSIGNMENT OF THE AWARD

- Candidates who possess the requirements prescribed by Art. 2 will be ranked on the basis of the following criteria:
 - Average mark of the partial exams: up to 70 points;
 - Attendance: up to 10 points;
 - Curriculum vitae et studiorum: up to 20 points.

- In assessing the curriculum vitae et studiorum, School of Law will take into consideration the following: age, years of graduation, study background, final mark, professional experiences and the certified knowledge of foreign languages.
- Only the top 5 (five) candidates of the ranking will access to the oral interview, to be held by the Selection Committee. In case of a tie, candidates that have attended the most number of class hours will be favoured. In case of further tie, the younger candidates will be favoured.
- Candidates selected for the interview will be informed through the email contact indicated in their application and must confirm their presence by e-mail by 2 working days from the communication. Should a candidate not confirming or attending the interview for any reason, he/she will be excluded from the selection process.
- The Selection Committee shall be composed by at least 3 members out of the following: Silvio Martuccelli, Simone Bernard de la Gatinais, Emanuele Barberis, Sara Molina, Federica Barella, Gilberto Nava. The Selection Committee will be integrated by the Academic Coordinator of the Master in Fashion Law to take part to the procedure without voting rights.
- The Selection Committee will proceed to interview the successful candidates during the month of October 2020, evaluating their skills and maturity, their specific professional aptitude for the field considered, as well as their background of studies and professional experiences. Additionally, the Selection Committee will interview candidates on substantial issues related to fashion law, to be chosen among those covered during the Master. Also, the Selection Committee will take into consideration for its deliberation the graduation thesis of the candidates admitted to the oral interview, pondering the relevance of the issues covered; clarity; ability to arguments logically and correctly; and to advance solutions for the legal problems analysed.
- The Selection Committee, in its sole discretion, shall create a final ranking, applying a maximum total of 50 points per candidate. In case of a tie, the candidate that have attended the most number of class hours will be favoured. In case of further tie, the younger candidate will be favoured.

ART. 5 - RESULTS AND FORMAL ACCEPTANCE

- The Selection Committee shall verify the formal regularity of the procedure and announce the winner of the "Chiomenti Fashion Law Award". The Selection Committee bears the full responsibility of the selection procedure and its decision ought to be considered final.
- The winner will be informed using the email contact indicated in its application. Within five days from the date of this communication, the winner must communicate to the Luiss School of Law its formal acceptance and send

- any other requested documents. Failing to do so, the Selection Committee will move to the following candidate on the list.
- The "Chiomenti Fashion Law Award" will be paid by transfer to a bank account. To this end, the winner must provide Luiss School of Law with its bank details for the transfer.
- Luiss School of Law reserves the right to carry out checks on the procedure. In the case of any discrepancy between what has been declared and what has been verified, the prize will be withdrawn, and any further action envisaged by the law initiated.

ART, 6 - PROCESSING OF PERSONAL DATA

- Luiss (Libera Università Internazionale degli Studi Sociali Guido Carli), as Controller, collects and processes data subjects' information in full compliance with the general principles and rules laid down by the law governing the protection of personal data (Legislative Decree No. 196/03 and Regulation (EU) No. 2016/679).
